Do we send personal information overseas?

Dolphin Plastics is likely to disclose some of your personal information overseas, for the purposes described above, to organisations in other countries including New Zealand, Singapore, the United States of America and the United Kingdom.

Some of these countries may not have the same or substantially similar privacy laws as those set out in this Privacy Policy and the Australian Privacy Principles. We may not require organisations to which we disclose personal information in those countries to comply with similar privacy principles, and accordingly your personal information may not receive the same protections that it would in Australia. By providing your personal information to us, you consent to our disclosure of your personal information to organisations in those countries even though it may not receive the same protections that it would in Australia and acknowledge that we will not be liable to you for any breach of the Australian Privacy Principles by these overseas organisations.

How do you access and/or correct your personal information?

Dolphin Plastics will take reasonable steps to ensure the information we collect, use or disclose is accurate, complete and up to date. However, we rely on you to advise us of any changes to your information or corrections required to the information we hold about you. Please let us know as soon as possible if there are any changes to your personal information, such as your address, phone number or bank details, or if you believe the information we hold about you is not accurate, complete or up-to-date.

At your request, we will provide you with a copy of any personal information which we hold about you, unless:

- the information is evaluative opinion material obtained confidentially in the course of our performing reference checks. In many cases evaluative material contained in references that we obtain will be collected under obligations of confidentiality that the person who gave us that information is entitled to expect will be observed. We do refuse access if it would breach confidentiality;
- access would impact on the privacy rights or other people; or
- otherwise required or permitted by law.

We will notify you of the basis for any denial of access to your information.

If you find that personal information that we hold about you is inaccurate, out of date, incomplete, irrelevant or misleading, you can ask us to correct it by contacting us. Within a reasonable time of obtaining a request (usually 30 days), we will take such steps as are reasonable in the circumstances to correct that information to ensure that, having regards to the purpose for which it is held, the information is accurate, up to date, complete, relevant and not misleading.

If we have disclosed personal information about you that is inaccurate, out of date, incomplete, irrelevant or misleading, you can ask us to notify the third parties to whom we made the disclosure and we will take such steps (if any) as are reasonable in the circumstances to give that notification unless it is impracticable or unlawful to do so.

What if you have a complaint?

You have a right to complain about our handling of your personal information if you believe that we have interfered with your privacy. If you are making a complaint about our handling of your personal information, it should first be made to us in writing by using the contact details below.

You will need to provide us with sufficient details regarding your complaint, as well as any supporting evidence and/or information. When we receive your complaint:

- we will take steps to confirm the authenticity of the complaint and the contact details provided to us to ensure that we are responding to you or to a person whom you have authorised to receive information about your complaint;
 upon confirmation we will write to you to acknowledge receipt and to confirm that we are handling your complaint in accordance with our policy.
 we may ask for clarification of certain aspects of the complaint and for further detail;
 we will consider the complaint and may make inquiries of people who can assist us to established what has happened and why;
 we will require a reasonable time (usually 30 days) to respond;
 if the complaint can be resolved by procedures for access and correction we will suggest these to you as possible solutions;
- if we believe that your complaint may be capable of some other solution we will suggest that solution to you, on a confidential and without prejudice basis in our response.
 If the complaint cannot be resolved by means that we propose in our response, you may contact us to discuss your concerns or take your

How Dolphin Plastics stores and protects personal information

Dolphin Plastics stores personal information in hard copy and electronic format using a combination of storage facilities including archives, servers, cloud storage and portable electronic devices. In so doing, we take reasonable steps (including any measures required by law) to protect your information from misuse, interference and loss, and unauthorised access, modification or disclosure. Furthermore, we take reasonable steps to destroy or permanently de-identify personal information when we no longer require it. Any information stored on our systems is protected from unauthorised access through the use of security procedures, including secure user logons and passwords. Our staff are committed to following these security procedures.

We take reasonable precautions to ensure that any information you provide to us through our website or via email is transferred securely. The Dolphin Plastics website monitors internet privacy and security threats. Any identified threats are evaluated and measures are taken to eliminate or reduce them.

However, no data protection and security measures are completely secure. Despite all the measures we have put in place, we cannot and do not guarantee the security of your information, particularly in relation to transmissions over the internet. Accordingly, any information which you transmit to us is transmitted at your own risk. You must take care to ensure you protect your information (for example, by protecting usernames and passwords etc) and you should notify us as soon as possible after you become aware of any security breaches.

Cookies

The Dolphin Plastics website uses cookies to track user traffic patterns. A cookie is a small data file that a website may write to your hard drive when you visit it.
